Our approach to meeting the Products & Services Outcome and Price & Value Outcome – Information for distributors of the Product

Whilst Buy to Let lending is outside the scope of Consumer Duty rules, we have taken the voluntary decision to apply the same PRIN principles to our Buy to Let Lending, and this summary document is being provided to you to fulfil our responsibilities under PRIN 2A.4.15R and PRIN 2A.3.12 R (2).

It is designed to support you to comply with your responsibilities under PRIN 2A.3.16 R and PRIN 2A.4.16 R. Please note that you are ultimately responsible for meeting your obligations under 'The Consumer Duty'.

## 1. Summary of our assessment

We have assessed that:

- Our Buy to Let product range continues to meet the needs, characteristics, and objectives of customers in the identified target market.
- The intended distribution strategy remains appropriate for the target market.
- The Product provides fair value to customers in the target market (i.e. the total benefits are proportionate to total costs).

#### 2. Product characteristics & benefits

The products are designed to meet the needs of the target group, most notably where customers required finance to purchase a property that they would like to let out. The product features and criteria are designed to support these needs.

- Choice of repayment methods, Repayment, interest only (subject to lending criteria) or part and part repayment.
- Mortgage Terms of up to 25 years
- The ability to port your mortgage product rate to a new property without incurring Early repayment charges (subject to lending criteria at the time)
- The ability to overpay on your mortgage without penalty, up to 10% of your outstanding mortgage balance per calendar year.
- Landlords with 4 or more mortgaged BTL properties.

The Product is not designed for customers who:

- Borrowing entities outside the UK including beneficial ownership outside the UK.
- Loans secured on property outside UK
- Debt size No greater than £5m for a single loan, and total loan value of £15m for a counterparty connected by legal liability
- · Funding highly leveraged debt transactions.
- Business where there is a private equity house in place.
- · Syndicated loan basis
- Industry sectors out with risk appetite.
- Customer who intend to live at the property
- Do not meet our lending criteria.

## 4. Customers with characteristics of vulnerability

The Product is designed for customers who would benefit from a fixed monthly repayment for a defined period of time, which is likely to include some customers with characteristics of vulnerability or who will experience vulnerability over time.

We considered the needs, characteristics, and objectives of customers with characteristics of vulnerability at all stages of the design process for this Product to ensure the Product meets their needs.

We have also tested the Product to assess whether it will meet the identified needs, characteristics, and objectives of the target market, including customers in the target market who have characteristics of vulnerability.



We have a business framework to achieve good outcomes for vulnerable customers, which includes:

- Group training to ensure colleagues have the knowledge and skills in relation to identification, treatment and consideration of customer vulnerability.
- Defined processes for tracking, review, contact strategy, desired outcome and data update.

Intermediaries should continue to comply with your obligations to ensure that you treat customers in vulnerable circumstances fairly.
